

## **EXECUTIVE SUMMARY: California Nursing Jobs Report Card**

The 2010 California Report Card of RN jobs per capita provides an excellent comparison of the RN workforce in different areas of California, as well as comparing California with other states. The survey is based on metropolitan statistical areas (MSA) or primary MSAs (PMSA) and was first conducted in 2005 utilizing data from 2004. Analysis of the RN workforce at the regional level supports development and implementation of regional policy and strategies to address nursing workforce issues. Although California's RN job ratio per capita increased by 22 RN jobs in the six years between 2004 and 2010, California's ranking relative to the rest of the county did not change.

## Methods

- ◆ The measure of the RN population used for the study is the RN jobs per capita the number of RN positions filled for 100,000 persons of the general population. The per capita value allows comparisons to be made based on RN job "density"- a useful measure of the RN workforce.
- ◆ The values for RN jobs for each state and California's P/MSAs were provided by the Bureau of Labor Statistics with California information provided by the California Employment Development Department.
- ◆ The grading rubric was constructed based on the 2010 national value of RN jobs per 100,000 population and on the standard deviation among the 2010 RN jobs per 100,000 population values of the 50 states and the District of Columbia. The standard deviation was found to be 198.
- ◆ Each of 23 California P/MSA regions was given a letter grade using the rubric to generate a report card for each region, which was further grouped by Northern, Central, or Southern California¹. The 23 regions represent the state's largest 33 counties (58 counties in California).
- ◆ In addition to the 23 California regions, RN jobs ratios were calculated for the entire United States, each of the 50 states and the District of Columbia, using the formula:

Number of RN jobs x 100,000 = RN jobs per 100,000 population.

♦ Both the Bureau of Labor Statistics and California Economic Development Department define an RN as a full-time or part-time employee, representing salaried employment; thus the Report Card represents the number of RN jobs that were filled – e.g. employment taxes paid – *not* the number of RNs working in a region.

## **Results**

The 2010 national average number of RN jobs per 100,000 was 860 (787 in 2004), representing a grade of C. *By comparison, California received a D with an RN job ratio of 644 (622 in 2004)*. Most P/MSAs retained the same grade as they had in 2004.

- ◆ All California P/MSAs fell below the national average with the exception of the San Francisco and Redding P/MSAs, with ratios of 960 and 857.7 respectively.
- ◆ Four P/MSAs received F's, indicating a ratio less than 462 RN jobs per capita RN jobs per capita: Fresno, Bakersfield, Oxnard-Thousand Oaks-Ventura, and Merced. (A ratio of 320 represented an F in 2004)
- ♦ The most common grade received in California was a D, received by 10 P/MSAs.
- ◆ Five P/MSAs improved their grades: located in Orange County, Central Coast; Chico-Paradise, and San Diego County.
- ◆ Five P/MSAs' grades dropped from 2004: all three San Francisco Bay Area PSAs, Redding, and Fresno.

The District of Columbia and forty states received a C or above, representing 761 jobs per capita or better. Eighteen states and DC received C+ or greater, representing 960 jobs per capita. Only three other states received Ds, along with California: Arizona, Nevada, and Utah.
