The work was conducted over 18 months in partnership with California's leading nursing organizations: American Nurses Association, California; Association of California Nurse Leaders/California Nursing Student Association; California Board of Registered Nursing (BRN); California Association of Colleges of Nursing; and California Organization of Associate Degree Nursing Program Directors North and South. Addressing the aim of identifying innovative strategies for change and new priorities for action, the report provides a framework for preparing future nurses to advance health in a changing healthcare environment. ## NCSBN National Nursing Workforce Survey

The National Council of State Boards of Nursing partnered with The National Forum of State Nursing Workforce Centers in 2015 to conduct the only national-level survey specifically focused on the U.S. nursing workforce. Information from the study supports planning for a well-prepared nursing workforce to meet the health care needs of the nation, ensuring a safe, diverse, accessible, and effective health care system.
