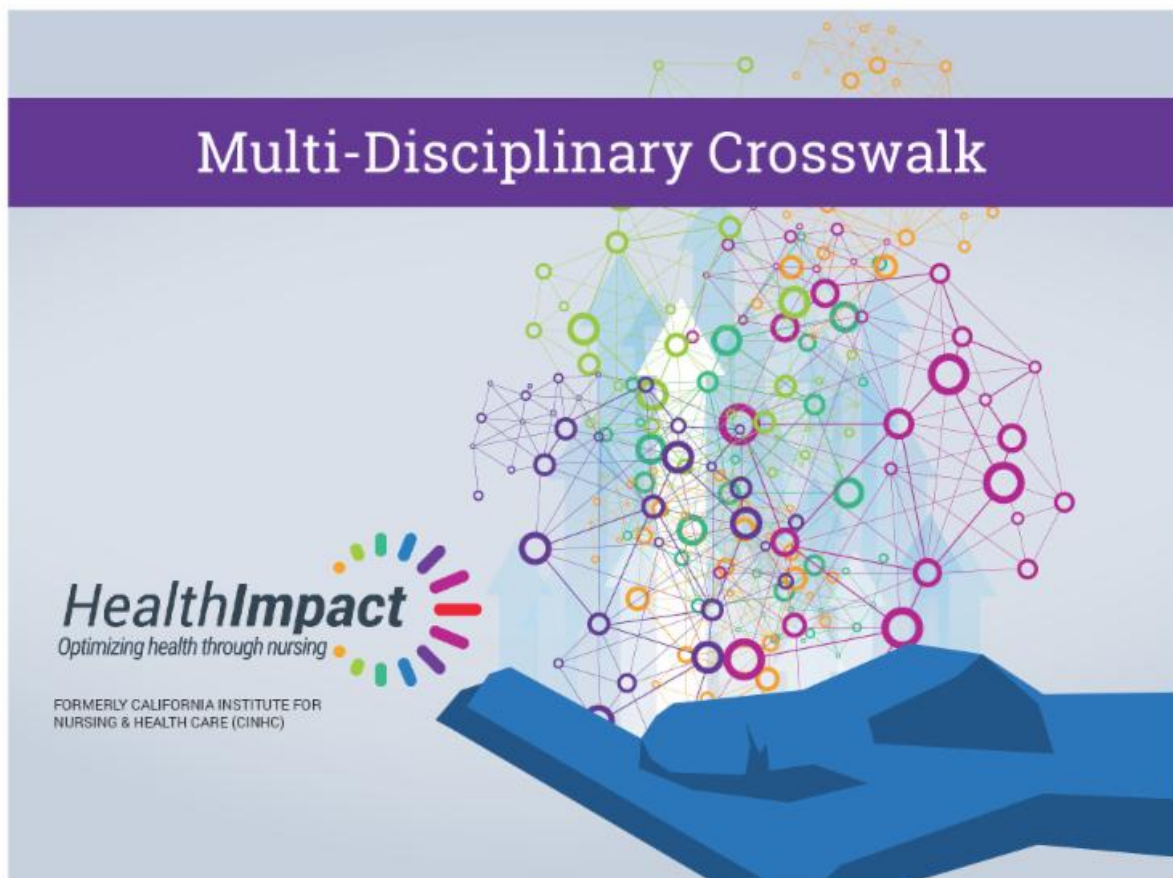

## **Important Update on BRN Fingerprinting Issue**

**RNs who fail to submit fingerprints to the BRN will be unable to renew their licenses and may face fines and disciplinary action.**

In December, the BRN sent letters to RNs across the state who do not have FBI or Department of Justice (DOJ) fingerprints on file. BRN Executive Officer Dr. Joseph Morris reports that many RNs have not responded.

**Failure to submit fingerprints within 60 days of the initial letter may result in a citation and fine up to \$2,500 or referral to the Attorney General's Office for possible disciplinary action.**

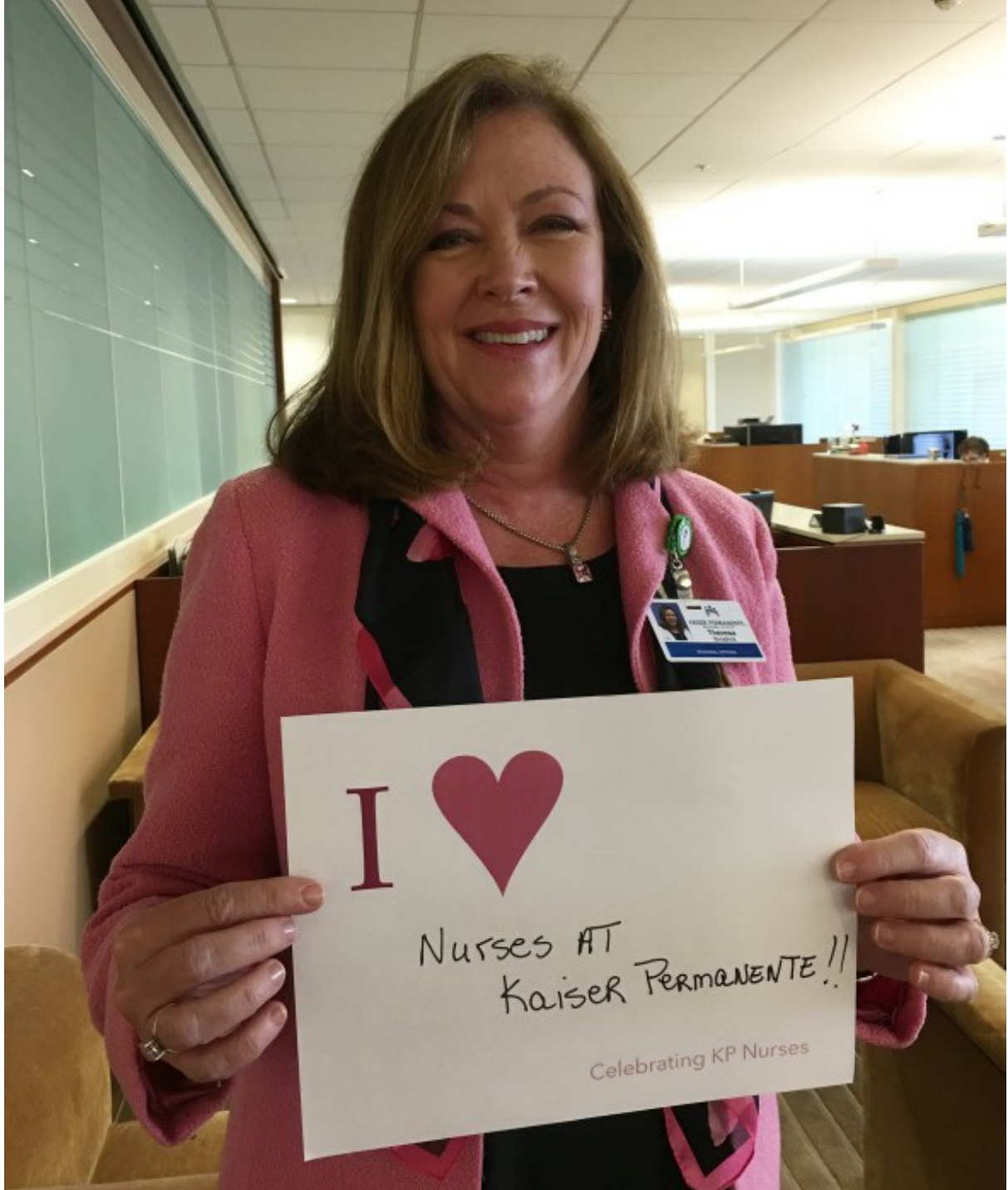

## NURSECorps Loan Repayment Program Deadline is February 23

HRSA's Bureau of Health Workforce has opened the application cycle for the program that supports RNs, APRNs, and nurse faculty by paying up to 85% of their unpaid nursing education debt. To receive loan repayment, nurses must work full-time at an eligible, accredited school of nursing or an eligible Critical Shortage Facility (CSF). Participants will join thousands of NURSE Corps members across the nation to meet the health care needs of underserved communities, including rural areas, and ensure a strong and sustainable nursing workforce for the future.
